





ADAPTATION AND INTEGRATION COURSE

The Course is mandatory for selected groups of foreigners who have newly arrived in the Czech Republic and obtained long-term or permanent residency (the biometric card) after 1, 1, 2021. You must take the course at latest within 1 year from the date when you received the card. In case you fail to fulfil this obligation, you risk being subject to a fine of up to CZK 10,000.

WHAT?

The Adaptation and Integration Course is a four--hour educational seminar about the Czech Republic, which will help you get oriented in the new country as soon as possible and get acquainted with your basic rights and obligations.

HOW?

You need to register for the course via the MOI portal: www.frs.gov.cz/kurzy. The CZK 1,500 fee is paid in advance during registration. You can find the registration guide at www.aik.icpraha.com
